CEU's

Earn 1.5 CEU's while participating in this seminar. Please be sure to sign the attendance roster for NRPA's records before you leave the seminar. NRPA will forward you a transcript of your attendance 6-8 weeks after the course is finished.

CERTIFICATION

You will receive notification with your exam results 6-8 weeks after the exam directly from NRPA. If you pass the exam you will be certified as a CPSI Inspector for a period of three years. At the end of your certification cycle you can elect to attend the course again (recommended) or elect to take the exam only. Due to changes in regulations and content it is highly recommended your repeat the course work prior to renewing your certification.
